This is an all-new review book that can be purchased alone or with additional CD-ROM-carefully preparing law school candidates for the all-important law school admission tests. The introductory chapters explain the LSAT format, offer a detailed three-month training plan for success, and submit a diagnostic test with explained answers. It is also important to note that in addition to one real LSAT practice, all other LSAT practice issues are compiled by the company; they are not official LSAC released issues. The Barron's LSAT test preparation is by far the cheapest option when it comes to preparing for LSAT. However, it is important to keep in mind that this is also a very bare bone approach to LSAT training. The book comes with an introductory chapter that explains LSAT, a three-month plan to get the score you want, and comes with a diagnostic test as well. The rest of the book delves into everything and all logical reasoning, understanding of reading, analytical reasoning, and LSAT essays. Included in each chapter of the study book are tips, strategies for passing the exam explained, reasoning behind the answers explained strategies for time control, and sample test with answers explained. In addition, the book comes with access to two online LSATs practice, complete with time-test sections, explained answers, and automated scoring. It also gives access to one actual LSAT exam and answers explanations. It is important to note that Barron uses made up questions to reflect what students will see on LSAT rather than actual LSAC released issues like most other preparation test to do. The diagnostic test should help students identify their strengths and weaknesses, which is valuable trying to increase LSAT scores. The graphics in the back were helpful though, in order to give me a better idea of what my chances would actually get into what law school. I read this a couple of years ago when I was still planning to take LSATs. It was quite helpful back then. I just didn't take them. Don't think I'm going to go back to it though, so the ranking now probably makes sense. A good base to start exploring, but I would recommend getting some supplements or checking out some websites for learning some research hacks. For those with less time or economic resources, Barron's book can provide comprehensive preparation for LSATs.
